**1951 27676      Creation, etc.**

Created Fort Myers Beach Fire Control District to include all parts of Lee County on San Carlos and Estero Islands; directed Governor to appoint a 3-member board to serve for 4 years unless removed for cause; members receive no compensation; board to select officers; established powers and duties of the board, including acquisition of fire department and equipment, levy of taxes, issuance of warrants, financial reporting

**1953 29241      Levy of taxes.**

Revises procedures for the levy of taxes.

**63-1539      Addition of lands to the District.**

Extends the boundaries of the district to include the easterly 1/2 of S13, T46 South, Range 23 East; westerly 1/2 of S18, T46 South, R 24 East; and the westerly 1/2 of S7, T46 South, R24 East, except that part which is located north of the old railroad grade.

Authorizes the district to maintain a fire and rescue department, give first aid, perform rescues, provide ambulance and advanced life-support services; hire personnel, and borrow money; vests authority to levy millages taxes in the board; provides procedures for levy, assessment and collection of taxes.
